# 1) Call to Order by Manager

- **2) Motion to approve Minutes of March 9, 2013 –** On a motion by Ernie Hayfield, 2<sup>nd</sup> by Chip Callori the minutes were approved, all in favor.

# 3) Management and Committee Reports:

- a) Finance Committee The quarterly finance report will be presented at the next meeting
- b) Design Review Committee
  - i) Unapproved Pool Installation A follow-up letter was sent requesting a response to bring account current and also meet DRC requirements for the pool installation.
- c) Safety Committee:
  - Security Report/Officer Shelly's Report There were seven false alarm reported in the past month and one domestic dispute with no arrests. Officer Shelly also reported that Kevin Transue and Jennifer Lyons have been promoted to Lieutenant.

# 4) Old Business:

- a) Route 447 Road and Drainage Patrick provided an update on his discussions with State Representative Rosemary Brown and Stroud Township Supervisors regarding the failed drainage along 447 and the intersection of Brushy Mt Road. He also provided an update on the written correspondence he has had with Penn DOT. He has been advised that Penn DOT and the township will be repairing the roadside swale this year. Also discussed was a capital improvement fee paid to the township by the Developers of Blue Mountain Lake, and other properties developed along Brushy Mt. Road (Cornerstone and Mt. Hollow), and whether those monies could be used by the Township to correct the problem and improve the intersection. He and counsel will continue to address this matter with the township and local officials.
- b) Walking Trail Wetland Permit no new information
- c) Infrastructure Grant Application no new information
- d) Cornerstone Counsel updated the Board, informing all present that the township had reported they levied on the infrastructure Bond posted by the Developer, LTS. It was explained that this bond would be the source of funds used to complete the infrastructure for that property. He will continue to monitor the situation.
